ACCOUNT DISCLOSURES

Except as specifically described, the following disclosures apply to all of the accounts. All accounts described in this Truth-in-Savings Disclosure are share accounts.

1. RATE INFORMATION — The annual percentage yield is a percentage rate that reflects the total amount of dividends to be paid on an account based on the dividend rate and frequency of compounding for an annual period. For Regular Share (Savings), Venture High Yield Savings, IRA (Traditional or Roth), Coverdell Education, C.U.M.M.A. (Credit Union Money Management), Traditional, Roth or Coverdell C.U.M.M.A., and Share Draft (Checking) accounts, the dividend rate and annual percentage yield may change at any time as determined by the Credit Union's Board of Directors. For Advantage Checking accounts, the dividend rate and annual percentage yield may change monthly as determined by the Credit Union's Board of Directors. The dividend rates and annual percentage yields are the rates and yields as of the last dividend declaration date that is set forth in the Rate Schedule. C.U.M.M.A. (Credit Union Money Management), Traditional, Roth or Coverdell C.U.M.M.A., and Advantage Checking accounts are tiered rate accounts. The balance ranges and corresponding dividend rates and annual percentage yields applicable to each tier are disclosed in the Rate Schedule. For C.U.M.M.A. (Credit Union Money Management) and Traditional, Roth or Coverdell C.U.M.M.A. tiered accounts, once a particular range is met, the dividend rate and annual percentage yield for that balance range will apply to the full balance of your account. For Advantage Checking accounts, each dividend rate will apply only to that portion of the account balance within each balance range. The Venture High Yield Savings account is a stepped rate account. The initial dividend rate on your Venture High Yield Savings account is the first rate listed for this account in the Rate Schedule. After that time, the second rate listed for this account will be paid every month. The annual percentage yield for this account is set forth in the Rate Schedule.

2. PERKS CHECKING ACCOUNTS — For Perks Checking accounts, you may qualify for monthly rewards if you meet the applicable minimum qualification requirements for the monthly qualification cycle. Your monthly service fee will be waived when you: 1) make 25 debit card purchases (minimum of \$5.00 per purchase) that post and settle your account; 2) have a minimum of \$500.00 in direct deposits that post and settle your account; 3) are enrolled to receive e-statements. If you meet all of the minimum qualification requirements, your monthly service fee will be waived. The monthly qualification cycle is defined as the period beginning on the 24th of the calendar month through the 23rd of the calendar month. Account transactions may take one or more business days from the date the transaction was made to post and settle to the account.

3. NATURE OF DIVIDENDS — Dividends are paid from current income and available earnings after required transfers to reserves at the end of the dividend period.

4. DIVIDEND COMPOUNDING AND CREDITING — The compounding and crediting frequency of dividends and the dividend period applicable to each account are stated in the Rate Schedule. The dividend period is the period of time at the end of which an account earns dividend credit. The dividend period begins on the first calendar day of the period and ends on the last calendar day of the period.

5. ACCRUAL OF DIVIDENDS — For all earning accounts, dividends will begin to accrue on noncash deposits (e.g. checks) on the business day you make the deposit to your account. For Venture High Yield Savings and Advantage Checking accounts, if you close your account before accrued dividends are credited, you will not receive the accrued dividends.

6. BALANCE INFORMATION — To open any account, you must deposit or already have on deposit the minimum required share(s) in a Regular Share (Savings) account. Some accounts may have additional minimum opening deposit requirements. The minimum balance requirements applicable to each account are set forth in the Rate Schedule. *For Advantage Checking accounts,

there is a minimum average daily balance and direct deposit of \$1,000.00 or more required to avoid a service fee for the dividend period. If the minimum average daily balance and direct deposit requirement is not met, you will be charged a service fee as stated in the Schedule of Fees and Charges. For Regular Share (Savings), Venture High Yield Savings, and Share Draft (Checking) accounts, there is a minimum daily balance required to earn the annual percentage yield disclosed for the dividend period. If the minimum daily balance requirement is not met each day of the period, you will not earn the annual percentage yield stated in the Rate Schedule. For accounts using the average daily balance method as stated in the Rate Schedule, Dividends are calculated by applying a periodic rate to the average daily balance in the account for the dividend period. The average daily balance is calculated by adding the principal in the account for each day of the period and dividing that figure by the number of days in the period. For accounts using the daily balance method as stated in the Rate Schedule dividends are calculated by applying a daily periodic rate to the principal in the account each day.

7. ACCOUNT LIMITATIONS — For Regular Share (Savings), Regular Share (Non-Dividend Bearing Savings), IRA (Traditional or Roth), Coverdell Education, C.U.M.M.A. (Credit Union Money Management), and Traditional, Roth or Coverdell C.U.M.M.A. accounts, you may make no more than six (6) transfers and withdrawals from your account to another account of yours or to a third party in any month by means of a preauthorized, automatic, or Internet transfer, by telephonic order or instruction, or by check, draft, debit card or similar order. If you exceed these limitations, your account may be subject to a fee or be closed. For IRA (Traditional or Roth) and Coverdell Education accounts, withdrawals require you to sign a statement of intent. For C.U.M.M.A. (Credit Union Money Management) and Traditional, Roth or Coverdell C.U.M.M.A. accounts, transfer and withdrawals must be in increments of \$500.00. The Venture High Yield Savings account is only available to members who receive AMOCO Investment and

Retirement services. For Advantage Checking accounts, one account is allowed per social security number. For Venture High Yield Savings, Share Draft (Checking), Share Draft (Non-Dividend Bearing Checking), Everyday Checking, Reset Checking, Perks Checking, and Advantage Checking accounts, no account limitations apply.

8. FEES FOR OVERDRAWING ACCOUNTS — Fees for overdrawing your account may be imposed on each check, draft, item, ATM transaction and one-time debit card transaction (if member has consented to overdraft protection plan for ATM and one-time debit card transactions), preauthorized automatic debit, telephone initiated withdrawal or any other electronic withdrawal or transfer transaction that is drawn on an insufficient available account balance. The entire balance in your account may not be available for withdrawal, transfer or paying a check, draft or item. You may consult the Membership and Account Agreement and Funds Availability Policy Disclosure for information regarding the availability of funds in your account. Fees for overdrawing your account may be imposed for each overdraft, regardless of whether we pay or return the draft, item or transaction. If we have approved an overdraft protection limit for your account, such fees may reduce your approved limit. Please refer to the Schedule of Fees and Charges for current fee information.

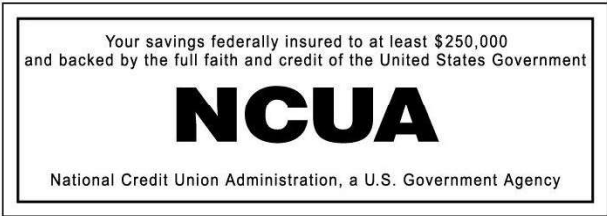
For ATM and one-time debit card transactions, you must consent to the Credit Union's overdraft protection plan in order for the transaction amount to be covered under the plan. Without your consent, the Credit Union may not authorize and pay an overdraft resulting from these types of transactions. Services and fees for overdrafts are shown in the document the credit union uses to capture the member's opt-in choice for overdraft protection and the Schedule of Fees and Charges.

9. MEMBERSHIP — As a condition of membership, you must purchase and maintain the minimum required share(s) as set forth below.

Identity Monitoring

Scans online sources known for illegally buying and selling personal information, such as your stolen passwords, Social Security number, and date of birth, and notifies you if your identity may be at risk. Activation for this benefit is required. To activate identity monitoring, please go to www.bazing.com, click on the Protection Category and follow the easy sign-up steps.



Roadside Assistance

The benefit provides roadside service for up to \$80 per occurrence limit. There will be one occurrence for the same service during any continuous seven-day period and a maximum of four services per twelve-month period. Covered services include towing assistance, battery service, flat tire assistance, fuel, oil, fluid, water delivery, lock-assistance, collision assistance and extrication assistance. BaZing Fuel

Earn rewards with BaZing Fuel to save at the gas pump. Get 10 cents or more per gallon just for activating and earn monthly rewards when you do the required debit card purchases from your BaZing checking account each month. Transactions must post and settle during each Monthly Qualification Cycle (MQC), which is defined as the first day of the month through the last day of the month. Also receive bonus rewards when the required number of additional transaction count is met. If the required monthly reward transaction count is not met during the MQC, no transactions are counted for any reward during that MQC or the bonus reward. Earned monthly and bonus rewards are applied and eligible for redemption the first day of the month following the MQC. Redeem BaZing Fuel at participating Shell Stations. BaZing Fuel is limited to 20 gallons of fuel per purchase. Once you begin to dispense fuel using your BaZing Fuel, you must dispense to the 20-gallon limit or you forfeit any remaining rewards for the other gallons. Other restrictions may apply. Review the full terms and conditions before activating BaZing Fuel in the mobile app.



Cell Phone Protection*

This insurance is to reimburse the enrolled account holder for damage to or theft of eligible Cellular Wireless Telephones. The enrolled checking account holder will receive a monetary reimbursement subject to the terms and conditions outlined in the Cellular Telephone Protection Guide to Benefits.

Overview of Coverage Information

1. Protection begins the first day of the calendar month following the payment of the Cellular Wireless Telephone bill using the eligible checking account associated with your BaZing membership.
2. Coverage is for the primary cell phone and up to two (2) secondary phones listed on the cellular billing statement.
3. You will be assessed a \$50 co-payment per claim.
4. Maximum of two (2) claims per 12-month period; maximum benefit \$1,000 per claim and \$2,000 per 12-month period.
5. If you fail to make a cell phone bill payment in a particular month, your protection is suspended. Coverage is reinstated the first of the month following the phone bill payment.
6. Only cellular phones purchased by eligible checking account holders are eligible.
7. Specific exclusions include pre-paid or "pay-as-you-go" phones, cosmetic damage that does not impact the phone's ability to make or receive calls, damage resulting from abuse or normal wear and tear, phones not purchased from a cellular service provider retail store or authorized reseller or Internet store.

Requirements Information

1. To submit a claim, you must notify BaZing by calling 855.822.9464 within 60 days of the phone being stolen or damaged. A claim form may be downloaded at BaZing.com or by calling BaZing.
2. When submitting a claim you must provide the completed claim form and all required documentation noted on the claim form and in the Cellular Telephone Guide to Benefits as determined by the Benefit Administrator. Claims must be submitted within 90 days of damage or theft.
3. To be eligible for this coverage, you must pay your cell phone bill from your eligible checking account associated with your BaZing membership.

Telemedicine

Members have 24/7 access to licensed clinicians (including physicians and nurse practitioners) who perform healthcare services through video or telephone via the Sesame telehealth platform. Members receive unlimited doctor visits, with a \$0 access fee for primary telehealth visits for the member only, face-to-face video conversations with a provider, prescription if recommended, urgent or routine care, referrals for specialists, and reduced rate for other services. This is not insurance.

Billshark helps you get the best rate from service providers for internet, cell phone, cable, satellite, home security, and more. Billshark can also find recurring subscriptions you no longer need and help with cancellation. BaZing members receive preferred pricing for Billshark services, which will be reflected in the cart at sign-up. Billshark requires activation.



Credit Monitoring

Credit IQ is a credit monitoring tool powered by Savvy Money. AMOCO members have access to daily credit-score updates, credit reports, personalized offers based on your credit score*, and financial articles to help you hit your credit score goals. Credit IQ is available in the eBranch – Online and Mobile Banking. In addition to your credit score, you will be able to see what positively and negatively impacts your score and get advice on how to improve it.
